- A proposal will be submitted to the management to develop a digital dashboard for OBE data tracking.

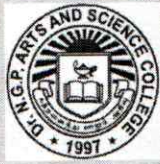

Resolution:

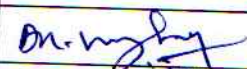
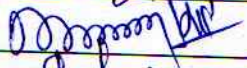
