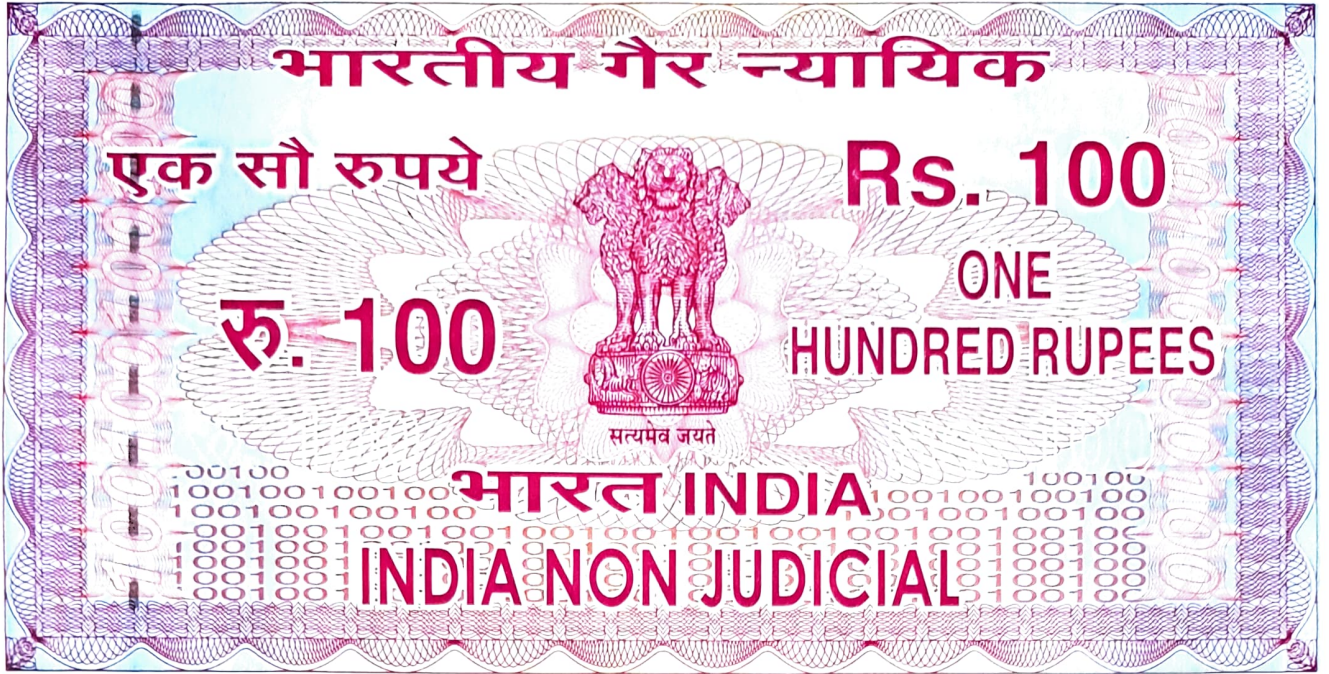

MEMORANDUM OF UNDERSTANDING

Between

Dr. N.G.P. Arts and Science College, Coimbatore

And

CSW Foundation, Coimbatore



This MEMORANDUM OF UNDERSTANDING is made and entered on Thursday, 11th March, 2025 between Dr. N.G.P. Arts and Science College, Tamil Nadu (Dr. NGPASC) on the ONE PART and the CSW Foundation, Coimbatore, on the OTHER PART (who for the purpose of this MoU are hereinafter individually referred to as "PARTY" and collectively referred to as the "PARTIES").

AND Whereas, CSW is involved in Field Work/Internship/Block Placement/Project in Social Work. The internships/Field work aims to provide students with practical, hands-on experience in their field of study, complementing their academic education with real-world skills and knowledge.

AND Whereas, Dr. NGPASC is involved in providing the eligible social work students for the Internship/Field work/Block Placement.

Now, therefore, in consideration of the premises and mutual covenants hereinafter contained, the parties hereto agree as follows:

Article 1. Objectives

- 1.1 To associate in providing Field Work trainings.
- 1.2 To provide Internship training.
- 1.3 To collaborate in organizing seminars and workshops.
- 1.4 To collaborate in conducting outreach programmes in the community.

Article 2. Responsibilities of the College

- 2.1 The college will provide the list of eligible students for the Internship/Field work.
- 2.2 The college will ensure that students will be prepared for Internship/Field work.
- 2.3 The college will appoint a faculty coordinator to liaise with the organization and monitor students' progress.

Article 3. Responsibilities of the Foundation

- 3.1 The foundation will provide students with a structured Internship/Field work program that offers relevant experience aligned with their academic discipline.
- 3.2 The foundation will assign a mentor or supervisor to guide and evaluate the interns/trainees.
- 3.3 The foundation will provide feedback on students performance to the College.
- 3.4 Give an assessment and certificate on successful completion.


Article 4. Implementation

- 4.1 The parties agree to constitute an Implementation Committee comprising the following Participants.
 - i) Principal, Dr. N. G. P. Arts and Science College, Coimbatore.
 - ii) Trustee and Secretary, CSW Foundation, Coimbatore.

Article 5. General Provisions

- 5.1 Based on the requirements the implementation committee shall, in consultation with the faculty and professionals, decide on field work / Internships / Project / Event and the mode of cooperation during the tenure of this Collaboration.

- 5.2 No monetary transactions are involved between the parties through this memorandum.
- 5.3 Each party shall bear the respective costs of carrying out the obligation under this agreement. Neither party shall make a claim against the other party for any expenditure unless such expenditure has been agreed upon in writing between the parties.
- 5.4 Any dispute or difference arising between the parties shall be settled by mutual agreement. The disagreements at the operating level shall be forwarded to the respective higher officials for appropriate resolution.
- 5.5 Nothing in this understanding is intended to affect other cooperation or collaboration between the Parties.

Article 6. Tenure and Termination

- 6.1 This MoU shall come into force in **11th March, 2025** upon signatures by the authorized signatories of the Parties and shall be **valid for three years**. It may be amended by mutual written agreement and may be terminated at any time by either party upon one month's written notice to the other party.
- 6.2 All joint activities not completed at the expiration or termination of this understanding may be continued until their completion under the terms of this understanding.


Article 7. Amendments

- 7.1 This MoU represents the entire understanding between the parties and supersedes any and all understandings either oral or written hitherto with respect to subject matter of this understanding.
- 7.2 No amendment or modification of the MoU shall be valid unless the same is made in writing by both the parties and specifically stating the same to be an amendment of the MoU. The modifications/ changes shall become part of the MoU and shall be effective from the date on which they are executed, unless otherwise agreed to.

Article 8. Assignment






