MEMORANDUM OF UNDERSTANDING

Between
DR.N.G.P ARTS AND SCIENCE COLLEGE
and
CITIZENS' VOICE COIMBATORE



This Memorandum of Understanding (hereinafter referred as "MoU") is made on 24.08.2023 in Coimbatore, Tamil Nadu, India by DR.N.G.P ARTS AND SCIENCE COLLEGE (Dr. N.G.P.ASC), Dr.N.G.P.Nagar, Kalapatti Road, Coimbatore-641 048, on the ONE PART and CITIZENS' VOICE COIMBATORE, a Society registered under Tamil Nadu Society's Act having its registered office at 814, old post office road (Near Collectorate), Coimbatore-641018.,on the OTHER PART (who shall be hereinafter individually referred to as a "Party" and collectively referred to as "Parties")

The Dr.N.G.P Arts and Science College.represented by its Principal i/c Prof.Dr.S.Saravanan (hereinafter referred to as "First Party", the institution which expression,unless excluded by or repugnant to the subject or context shall include its successors-in-office,administrators and assigns) and **CITIZENS' VOICE COIMBATORE** is represented by its authorized representative C.M. Jayaraman -President and V.A.Shanmugham -Secretary.

The first party, i.e. Dr.N.G.P.Arts and Science College (Dr. N.G.P.ASC) is an organization of Dr NGP Research and Educational Trust which was established in the year 1997 under the leadership of Dr. Nalla G Palaniswami, as its Chairman and Dr.Thavamani D Palaniswami as its Managing Trustee and Secretary.The College has been recognized under 2(f) and 12(B) by UGC, New Delhi.The college was re-Accredited by NAAC with A++ Grade (3rd Cycle-3.64 CGPA).

The second party,i.e.,**CITIZENS' VOICE COIMBATORE**, registered office at 814 old post office road (Near Collectorate), Coimbatore-641018, a Society registered under Tamil Nadu Society's Act.

WHEREAS:

- a) The CITIZENS' VOICE COIMBATORE has agreed to skill development through conducting workshops, Awareness Programs, surveys and competitions,to work with the existing laws in order to protect civic, consumer's interest and environmental awareness for students Secretary of Dr.N.G.P.Arts and Science College, Coimbatore.
- b) Towards this, the Parties hereby agree to enter into this Agreement to record their understanding in conducting workshops, Awareness Programs, surveys and competitions on terms and conditions as set out in this MoU.

NOW, THEREFORE,IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU,THE PARTIES HERETO AGREE AS FOLLOWS:



1. SCOPE OF THIS AGREEMENT

- 1.1 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of Second Party in providing conducting workshops, Awareness Programs, surveys and competitions for Citizen Consumer Club of the college and believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.
- 1.2 **ProgramDesign:** Second Party will give valuable inputs as per the schedule allotted by the First Party in conducting events to suitably customize the requirements.


INTELLECTUAL PROPERTY

Nothing contained in this MoU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

VALIDITY

This agreement is valid for a period of **one year** from the date of signing of this agreement by both the parties and shall automatically renew for successive one-year terms unless terminated by either party upon at least 60 days' written notice prior to the end of the then-current term. Either party can terminate this agreement in written communication by providing 60-day notice period. During the notice period it is agreed that both the parties will work towards a smooth transition, clear any pending deliveries for that particular period, clear pending dues if any.

In witness whereof, CITIZENS' VOICE COIMBATORE and DR.N.G.P.ARTS AND SCIENCE COLLEGE have caused this agreement to be executed by their duly Authorized representatives.



Services:

We share the common vision of empowering the students by imparting skill sets and increasing their employability.

To achieve our common goal, Dr.N.G.P.Arts and Science College and CITIZENS' VOICE COIMBATORE would collaborate on the following framework to execute the students' skill training.

Role of CITIZENS' VOICE COIMBATORE

1. To educate and cultivate civic, social and consumer awareness –water management & conservation, rain water harvesting etc., among the students.
2. To conduct various activities such as Consumer Awareness programs like Rally, Guest Lecture, Workshops, Field Visit - Local Markets & Consumer Court visit, Quiz Competition with their guidance and support etc.

Role of Dr.N.G.P.Arts and Science College

1. Provide adequate infrastructure to Conduct Awareness Programs, Quiz, workshops, testing lab facilities for water, milk, oil, petrol, pulses etc and competitions inside the Campus.
2. Approve time slot for conducting Rally and various activities for the students and general public.
3. The institution reserves the rights to cancel the MoU if it is dissatisfied with the training.

Representation and Warranties:

Each Party represents and warrants to the other as follows:

1. It shall during the term of this Agreement comply with all applicable laws, regulations, and regulatory requirements and codes of practice in carrying out its obligations under this Agreement and in all matters relating hereto, and shall not knowingly do anything or procure or permit anything to be done which might cause or otherwise result in a breach by the other Party of the same.



2. There is no litigation, claims, actions or governmental investigations of any nature pending against it and it has not received notice of any such legal proceeding, claim, action or governmental investigation against it nor has it any knowledge of any such threatened proceedings, claim, action or governmental investigation, which relates in any manner to this Agreement or the transactions contemplated hereby or which could adversely impact its ability to perform this Agreement.

Each party undertakes:

1. To co-operate fully with the other, and with the other's employees, agents and contractors, with a view to facilitating and enhancing the Parties performance of their respective obligations hereunder;
2. Not to use, publish or disclose any information or material produced or supplies by the other Party hereunder, without the other Party's prior written consent, for any purposes other than those contemplated under this Agreement; and
3. To promptly inform the other Party of any claims or complaints of which the informing Party becomes aware relating to the other Party or its activities in connection with its performance under this Agreement.

Entire Agreement:

This MoU constitutes the entire Agreement of the parties with respect to the subject matter of this MoU and supersedes all prior Agreements, understandings and negotiations with respect to such subject matter.


Renewal of Memorandum of Understanding:
