MEMORANDUM OF UNDERSTANDING

This institution is recognized under 2(f) & 12(B) and conferred autonomous status during the academic year 2015-16 by University Grants Commission, New Delhi and is accredited with A++ Grade (3rd Cycle) by NAAC. Eight science departments are recognized under DBT-STAR scheme.
- 6. **Drops Chemicals**, (GST No. 33AAFCE8673H1ZF), is an organization of which was established in the year 2004 and having its registered office at 3rd floor, No.76, East Power House Road, Gandhipuram, Coimbatore 641012. The Company is engaged in manufacturing, supplying and exporting of basic industrial chemicals, agro chemicals, water treatment chemicals, food chemicals, stripping services, acids and solvents, and hygiene products.
- 7. The Parties are desirous of entering into this Memorandum of Understanding (hereinafter be referred as "MoU") to declare their respective intentions and to establish a basis of cooperation and collaboration between the Parties upon the terms as contained herein.

THE PARTIES HAVE REACHED AN UNDERSTANDING ON THE FOLLOWING MATTERS

1. OBJECTIVE

1.1) The MoU sets out the framework and areas of academia-industry cooperation which may be of mutual interest and benefit to both Parties. In order to pursue the above objectives and forms of cooperation, either Party may also propose fields of cooperation of mutual benefit for consideration by the other Party.

2. AREAS OF COOPERATION

Both parties agree to encourage the following activities, in particular, to promote academia-industry cooperation in the following areas:

- 2.1) Organization of joint industry-academia workshops and seminars to bridge the gap between academia and industry practices.
- 2.2) Exchange of personnel for internships and hands-on training experiences.
- 2.3) Support for Internship and Placement.

3. EFFECT OF THIS MEMORANDUM OF UNDERSTANDING

This MoU is not intended to be legally binding but it simply expresses the intentions and understanding between both Parties. The Parties may enter into a legally binding Memorandum of Agreement while incorporating terms from this MoU.

4. NO AGENCY

The relationship between the Parties will be non-exclusive in nature. The MoU does not prevent a Party from entering into arrangements with other third parties. Nothing contained herein is to be construed so as to constitute a joint venture partnership or formal business organization of any kind between the Parties to make either Party the agent of the other.

5. ENTRY INTO EFECT AND DURATION

- 5.1) This MoU shall become effective from the date of signing by both Parties herein.
- 5.2) This MoU will remain in effect for a period of two (2) Years.
- 5.3) This MoU may be extended for such further period as agreed in writing by both Parties.

6. REVISION, VARIATION AND AMENDMENT

6.3) Such revision, variation or amendment shall come into force on such date as may be

determined by the Parties.

6.4) Any revision, variation or amendment shall not prejudice the implementation of any

project, activity or co-operation arising from or based on this MoU before or up to the date of

such revision, variation or amendment.

7. TERMINATION

This MoU may be terminated by either Party with a minimum of THIRTY (30) days written notice from one Party to the other. Activities in progress at the time of termination of

this MoU shall be permitted to conclude as planned unless otherwise agreed.

8. NOTICES

Any communication between the Parties under this MoU shall be in writing in the English language and delivered by registered mail to the postal address or sent to the electronic mail address as stated herein, be deemed to be duly given or made when

delivered to the recipient at such postal address or electronic mail address.

Each Party represents and warrants to the other as follows:

1. Resolution of Disputes:

a) This agreement shall take effect and be construed in accordance with the Laws of India and be subject to the jurisdiction of the courts at Coimbatore.

b) The dispute or difference whatsoever arises between Parties in relation to or in connection with this agreement both the parties shall first try to resolve the dispute/difference amicably between themselves, failing which the matter shall be referred to and settled through arbitration. its respective duties, obligations, and business practices of that Party and shall obtain
necessary permits or licenses for its operations. Neither Party shall take any action in
violation of any applicable legal requirement that could result in liability being imposed
on the other Party.

Entire Agreement:

This MoU constitutes the entire Agreement of the parties with respect to the subject matter of this MoU and supersedes all prior Agreements, understandings and negotiations with respect to such subject matter.

Renewal of Memorandum of Understanding:
