2. **EDU TANTR** is the second party, an EdTech organization that focuses on bridging the gap between academic learning and industry requirements. The company specializes in providing skill-based training, corporate-aligned internships, career development programs and academic collaborations for students and institutions across domains such as Full Stack Development, Cyber Security, AI & ML and Human Resource Management.
3. First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources and provide each of them with enhanced opportunities.
4. The Parties intent to cooperate and focus their efforts on cooperation in the areas of Skill-Based Training, Internship Opportunities, Joint Research Initiatives and Knowledge Exchange.

Both parties agree to encourage the following activities, in particular, to promote academia-industry cooperation in the following areas:

- 2.1) Joint initiatives in education and collaborative research.
- 2.2) Organization of industry-academia workshops, seminars and conferences.
- 2.3) Joint mentoring and guidance for hackathons, competitions and innovation challenges.
- 2.4) Exchange of training resources, project documentation and technical publications.
- 2.5) Collaborative support for academic projects, internships and student placements.

### **3. EFFECT OF THIS MEMORANDUM OF UNDERSTANDING**

### **4. NO AGENCY**

The relationship between the Parties will be non-exclusive in nature. The MoU does not prevent a Party from entering into arrangements with other third parties. Nothing contained herein is to be construed so as to constitute a joint venture partnership or formal business organization of any kind between the Parties or to make either Party the agent of the other.

### **5. ENTRY INTO EFFECT AND DURATION**

5.1) This MoU shall become effective from the date of signing by both Parties herein.

5.2) This MoU will remain in effect for a period of two (2) years.

5.3) This MoU may be extended for such further period as agreed in writing by both Parties.

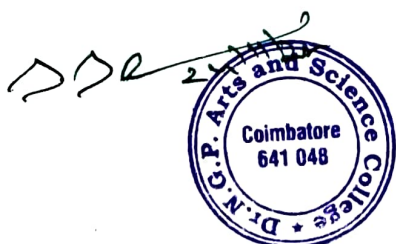
### **6. REVISION, VARIATION AND AMENDMENT**

**Each Party represents and warrants to the other as follows:**

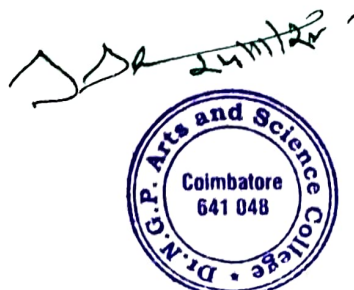

**Resolution of Disputes:**

- b) The dispute or difference whatsoever arises between Parties in relation to or in connection with this agreement both the parties shall first try to resolve the dispute/difference amicably between themselves, failing which the matter shall be

- This MoU constitutes the entire Agreement of the parties with respect to the subject matter of this MoU and supersedes all prior Agreements, understandings and negotiations with respect to such subject matter.


