### MEMORANDUM OF UNDERSTANDING

And

The LEDAA INTERNATIONAL, an experienced academy offering coaching for Chartered Accountancy / Cost& Management Accountant / Company Secretary Courses situated at Pathy's Tower, Kattoor Road, Gandhipuram, Coimbatore-641037, represented by its authorized representative Mr.D.Ramaswamy (hereinafter referred to as "Second Party", the

First Party and Second Party shall be hereinafter collectively referred to as "**Parties**" and individually as a "**Party**".

**The first party**, i.e., **Dr.N.G.P. Arts and Science College** (DrNGPASC) is an organization of KMCRET trust which was established in the year 1997 under the leadership of **Dr.Nalla G. Palaniswami**, as its Chairman and **Dr.Thavamani D. Palaniswami** as its Managing Trustee and Secretary. The College has been recognized under 2(f) and 12(B) by UGC, New Delhi. The college was re-Accredited by NAAC with "A" Grade (2<sup>nd</sup> Cycle).

**The second party**, i.e., **The LEDAA INTERNATIONAL** situated @ Gandhipuram, is an established Academic Institution offers training students for the Qualification of Chartered Accountancy/ Cost and Management Accountancy, Company Secretary and ACCA.


**WHEREAS:**

- A. The LEDAA INTERNATIONAL has agreed to provide coaching classes for the CMA & CSEET Foundation Classes for the interested Students of Dr.N.G.P. Arts and Science College, Coimbatore
- B. Towards this, the Parties hereby agree to enter into this Agreement to record their understanding in offering coaching classes for the foundation Courses of CA on terms and conditions as set out in this MoU

**NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:**

**1. SCOPE OF THIS AGREEMENT**

- 1.1 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of Second Party in providing CMA& ACS Foundation coaching within the campus of the First party both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.
- 1.2 **Curriculum Design:** Second Party will give valuable inputs as per the schedule allotted by the First Party in teaching methodology and suitably customize the curriculum.
- 1.3 **Coaching Classes:** Second Party will coach the Students through qualified CA/CMA/ ACS/ACCA. The list of Teaching Faculty in Annexure 2
- 1.4 **Guest Lectures:** Second Party to extend the necessary support to deliver guest lectures to the students of the First Party on the technology trends and in house requirements.
- 1.5 **Test Batches:** Along with the coaching, the students will be given test and evaluation



will be done, along with suggestions for improvements.

- 1.6 Second Party to take up program mentioned in the MoU. The financial consideration, is given separately in annexure 1, and is subject to modification from time to time, with the mutual consent of both parties.

### **CLAUSE 3 - INTELLECTUAL PROPERTY**

Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

### **CLAUSE 4 - VALIDITY**

This Agreement will be valid from the date of consent given by the First party and until it is expressly terminated by either Party on mutually agreed terms.

Both Parties may terminate this MOU before the commencement of the new upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations in respect to completion of coaching by the second party and pending financial consideration by the first party.

Any divergence or difference derived from the interpretation or application of the MoU shall be resolved by arbitration between the parties as per the Arbitration Act, 1996. The place of the arbitration shall be at District Head Quarters of the First Party.


