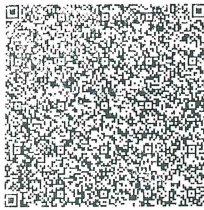

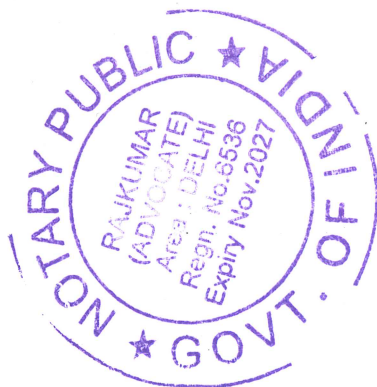

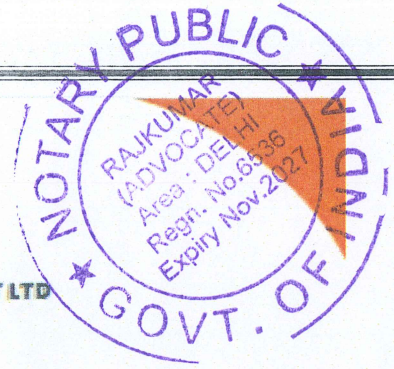

AND

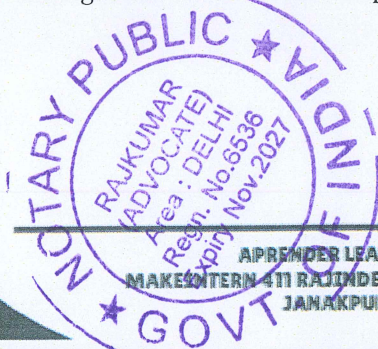

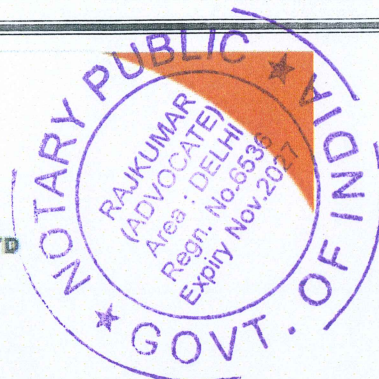

I. Responsibilities/Deliverables from the College's side:

- Shall nominate One Faculty Coordinator with adequate accountability and responsibility to coordinate the Training Program. He / She would act as the coordinator & point of contact for the proposed Programme.
- Shall make available the infrastructure (including IT infrastructure, applications and connectivity) required to conduct the Training Program.
- Shall provide all the support services and facilities to Makeintern during the conduct of the said Training Program. Adequate power backup through UPS and DG supplies during the training sessions.
- Shall coordinate with Makeintern and facilitate conduct of all the assessments.
- Shall share the details of students in a prescribed format to ensure that there is no duplication of beneficiaries.
- The College need to inform Makeintern well in advance for any of the training requirements and shall decide the schedule mutually.
- College need to look after the accommodation of Makeintern resource person coming for the training.

II. Responsibilities/Deliverables from the Makeintern:

- Makeintern will conduct **6 days (30 hours)** Training/Workshop in the College on the Topic Selected by the College as agreed mutually.
- Makeintern will select 5 Students From a Batch of every 50 Students on the basis of the evaluation conducted on the last day of the training and those students would be visiting IIM Bangalore Campus for the Championship Program
- Makeintern will also look after the accommodation arrangements of selected students and one faculty for 2 days.
- Makeintern will provide the Adequate Trainer/Faculty for the training Commencement on the dates decided mutually by the University and Makeintern.
- Makeintern will provide marketing Material (Posters & Banner) to promote the Training Program in campus.
- Makeintern will also assist the internship for all the participants and it will be valid till 19/08/2026
- The College will be honored by the excellence certificate.

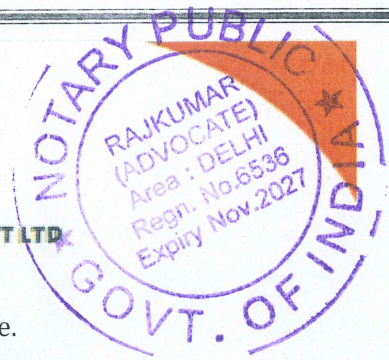
III. Commercials

Timeline: This agreement shall commence from 19.08.2025 till 19.08.2028 unless this Agreement is terminated pursuant to the provisions hereof.

Consideration: The Deliverables agreed here under the agreement shall be considered the sufficient consideration from each party for this Agreement; being yearlong association having no barter/ kind consideration.

1. The MOU may be extended further on mutual consent by both the parties.
2. Either Party may terminate this MOU at any time by giving not less than thirty (30) days notice in writing. At the end of the Thirty (30) days period calculated from the 1st day of the said notice, this MOU shall be terminated.

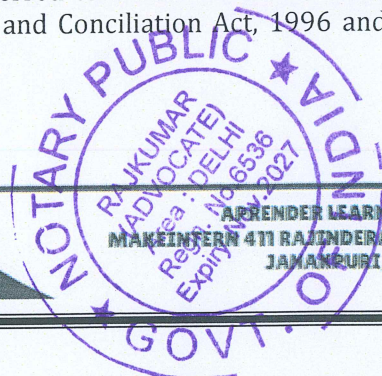
VI. Confidentiality

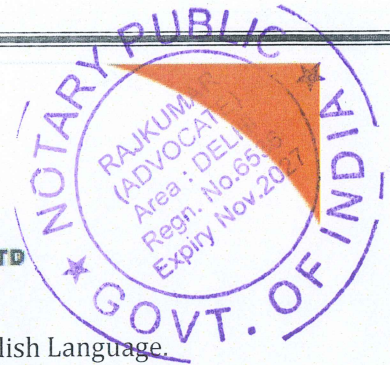

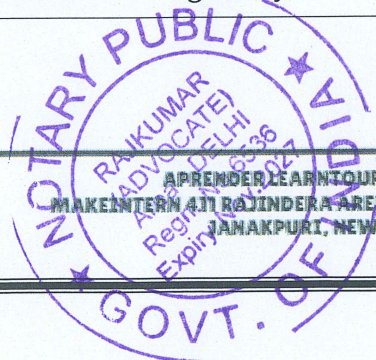
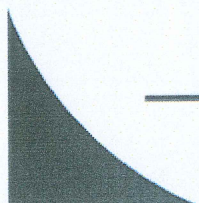
Coimbatore/Delhi and the Proceedings shall be conducted in Hindi/English Language.

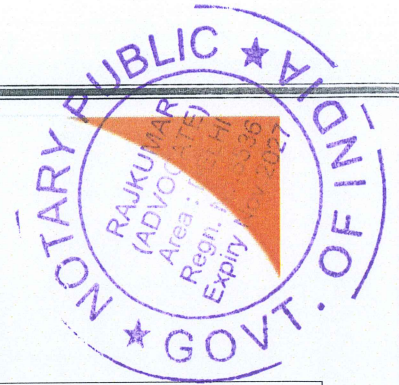
