MEMORANDUM OF UNDERSTANDING

Between

Dr. N.G.P. Arts and Science College, Coimbatore

And

My Body is My Body Foundation, Coimbatore



This MEMORANDUM OF UNDERSTANDING is made and entered into on Thursday, 06th March, 2025 between Dr. N.G.P. Arts and Science College, Tamil Nadu (Dr. NGPASC) on the ONE PART and the My Body is My Body Foundation, (hereinafter MBIMB), on the OTHER PART (who for the purpose of this MoU are hereinafter individually referred to as "PARTY" and collectively referred to as the "PARTIES").

AND Whereas MBIMB is involved in Child Abuse Prevention Education through Collaborative Community Outreach Programmes along with the Department of Social Work and Child Protection Club.

AND Whereas Dr. NGPASC is involved in providing the eligible students for the mobilization efforts and sensitization programmes in the community.

Now, therefore, in consideration of the premises and mutual covenants hereinafter contained, the parties hereto agree as follows:

Article 1. Objectives

- 1.1 To associate in providing Child Abuse Prevention Education programmes at Dr. NGPASC
- 1.2 To collaborate in organizing seminars and workshops.
- 1.3 To collaborate in conducting outreach programmes in the community.

Article 2. Responsibilities of the College

- 2.1 Initiate mobilization efforts to introduce the My Body is MY Body Programme in collaboration with the Indian Department of Education within schools and districts.
- 2.2 Carry out monitoring and evaluation activities to ensure the sustainability of the implemented programmes (Monitoring paperwork to be supplied by MBIMB)
- 2.3 Marketing of the vision and any media or other public relations contact should always be consistent with the aims of MBIMB and Dr. NGPASC, Social Work Department and Child Protection Club, and only undertaken with the express agreement of both parties. Where it does not breach any confidentiality protocols, a spirit of open and transparent communication should be adhered to.

Article 3. Responsibilities of the Foundation

- 3.1 Supply the Dr. NGPASC, Social Work Department with all its free resources branded with the Dr. NGPASC, Social Work Department logo.
- 3.2 Make available all of its Courses for the use of the Dr. NGPASC, Social Work Department and Child Protection Club.
- 3.3 Make available all of its Programme languages to Dr. NGPASC, Social Work Department and Child Protection Club.
- 3.4 Offer to do some additional training and Q and A's on Zoom as needed.

Article 4. Implementation

- 4.1 The parties agree to constitute an Implementation Committee comprising the following Participants.
 - i) Principal, Dr. N. G. P. Arts and Science College, Coimbatore.
 - ii) Founder and CEO, MBIMB Foundation, Coimbatore.

Article 5. General Provisions

- 5.1 No liability will arise or be assumed between the Partners because of this Memorandum.
- 5.2 No monetary transactions are involved between the parties through this memorandum.

- 5.3 In the case of a dispute, a dispute resolution group created by both parties will be set up. The dispute resolution group may receive for consideration any information it thinks fit concerning the dispute. The Partners agree that a decision of the dispute resolution group will be final. In the event the dispute resolution group is unable to make a compromise and reach a final decision, it is understood that neither party is obligated to enter into any binding contract to complete the Programmes.
- 5.4 Any notice or communication required or permitted under this Memorandum shall be sufficiently given if delivered in person or by certified mail, return receipt requested, to the address set forth in the opening paragraph or to such other address as one party may have furnished to the other in writing.
- 5.5 In no way does this agreement restrict involved Partners from participating in similar agreements with other public or private agencies, organisations, and individuals.
- 5.6 To the extent possible, each Partner will participate in the development of the Project. Nothing in this memorandum shall obligate any Partner to the transfer of funds.
- This Memorandum is not intended to and does not create any right, benefit, or trust responsibility.

- i) This Memorandum will be effective upon the signature of both Partners.
- ii) Any Partner may terminate its participation in this Memorandum by providing written notice to other Partner.
- iii) The following Partners support the goals and objectives of the Child Abuse Prevention & Education Project:
- iv) My Body is My Body Foundation (MBIMB) does not authorize or permit Dr. NGPASC, Social Work Department to present the MBIMB programme to children. This means that the Dr. NGPASC, Social Work Department will have to gain consent to present the programme through the Indian Department of Education.

Article 6. Tenure and Termination

- 6.1 This MoU shall come into force on **06th March, 2025** upon signatures by the authorized signatories of the Parties and shall be **valid for three years**. It may be amended by mutual written agreement and may be terminated at any time by either party upon one month's written notice to the other party.
- 6.2 All joint activities not completed at the expiration or termination of this understanding may be continued until their completion under the terms of this understanding.

Article 7. Amendments

- 7.1 This MoU represents the entire understanding between the parties and supersedes any and all understandings either oral or written hitherto with respect to the subject matter of this understanding.
