

## SERVICE AGREEMENT

This Agreement is entered into on this the 5th July 2021.

The following agreement is signed between

"Waste Value Chain", No Disposal, No.5,50ft Road, Krishnaswamy Nagar, Ramanathapuram, Coimbatore- 641045 (Hereinafter referred to as Party No.1)

AND

To cover the scope of solid waste management services of municipal waste, by Party 1 in the property of Party 2.

Whereas,

No Disposal is a unique technology enabled ecosystem between generator and processor in the waste management space. It provides customized handling and transportation for stream-based wastes, within the framework of Solid Waste Management Rules 2016

Bulk waste generators are required to either manage their waste themselves by Onsite Composting or outsource the waste to a competent authority, for scientific processing.

With onsite waste management requiring expertise and dedicated man-power, No Disposal has come forward to provide solid waste management services as per govt guidelines to Bulk waste generators, both domestic and commercial.

NGP engages in providing educational services, wherein waste management is one of the important compliance criteria.

### RESPONSIBILITIES OF PARTY 1

1. Provide transportation services for organic waste (daily) and dry waste (as required).
2. One trip for organic waste and one trip for dry waste, unless otherwise required.
3. Organic and dry waste will be transported by separate vehicles.
4. Organic waste logistics will transport ONLY clean organic waste, contraries will not be entertained. Organic Waste kept in green bins will only be taken.
5. Dry waste logistics will transport ONLY dry inorganic waste, contraries will not be entertained
6. Contraries leading to mixed waste will be communicated by email (initial one week period), to bring a correction in the collection/segregation process.

#### RESPONSIBILITIES OF PARTY 2

1. Segregate waste into organic and dry, kept packed in bins and bags.
2. Load waste to vehicle

Note: The service is only for general Municipal non - medical waste.

Any mixing of Bio-medical waste in Municipal waste is against MSWM rules 2016.

**TERM:**

This Agreement remains effective for a period of Three year from the date hereof.

**TERMINATION**

During the validity of this Agreement, both parties shall be entitled to terminate the same at any time, without assigning any reason, after giving three months prior notice to either side. Notwithstanding such termination, each party shall fulfill all obligations accrued under the agreement prior to the time termination becomes effective.
