# THE PARTIES HAVE REACHED AN UNDERSTANDING ON THE FOLLOWING MATTERS

### **1. OBJECTIVE**

1.1 The MoU sets out the framework and areas of academia-industry cooperation which may be of mutual interest and benefit to both Parties. In order to pursue the above objectives and forms of cooperation, either Party may also propose fields of cooperation of mutual benefit for consideration by the other Party.

### 2. AREAS OF COOPERATION

2.2) Organization of joint industry-academic workshops and seminars to bridge the gap between academia and industry practices.

# 3. EFFECT OF THIS MEMORANDUM OF UNDERSTANDING

#### 4. NO AGENCY

### 5. ENTRY INTO EFFECT AND DURATION

5.1) This MoU shall become effective from the date of signing by both Parties herein.

5.2) This MoU will remain in effect for a period of five (5) years.

5.3) This MoU may be extended for such further period as agreed in writing by both Parties.

#### 6. REVISION, VARIATION AND AMENDMENT

6.1) Either Party may request in writing a revision, variation or amendment of this MoU.

6.2) Any such revision, variation or amendment agreed to by the Parties in any clause of the MoU shall be mutually agreed by both the parties.

6.3) Such revision, variation or amendment shall come into force on such date as may be determined by the Parties.

6.4) Any revision, variation or amendment shall not prejudice the implementation of any project, activity or co-operation arising from or based on this MoU before or up to the date of such revision, variation or amendment.

### 7. TERMINATION

This MoU may be terminated by either Party with a minimum of THIRTY (30) days written notice from one Party to the other. Activities in progress at the time of termination of this MoU shall be permitted to conclude as planned unless otherwise agreed.

#### **8. NOTICES**

Any communication between the Parties under this MoU shall be in writing in the English language and delivered by registered mail to the postal address or sent to the electronic mail address as stated herein, be deemed to be duly given or made when delivered to the recipient at such postal address or electronic mail address.
