Palaniswami, as its Chairman and Dr. Thavamani D. Palaniswami as its Managing Trustee and Secretary. The college has been recognized under 2(f) and 12(B) by UGC, New Delhi. The college was reaccredited by NAAC with "A++" Grade (Third Cycle) and ranked no. 75 by NIRF.

The Second party, i.e., Shine IAS Academy & Shine School of Banking which was established in the year 2011 under the leadership of Mr. N. Hariharan at Coimbatore. This institution is providing services to competitive examinations for TNPSC, Banking, Indian Railway and SSC.

Purpose


