Memorandum of Understanding

This **Memorandum of Understanding** is intended to promote cooperation between Dr.N.G.P. Arts and Science College (Autonomous), Coimbatore (Herein after referred to as Dr. N.G.P. Arts and Science College), UGC approved, accredited by the NAAC with 'A++' Grade in the Third cycle, ranked no. 66 in NIRF, affiliated under the Bharathiar University, Coimbatore represented by its Principal Dr. S.Saravanan, Herein after referred to as the FIRST PARTY OF ONE PART

AND

SRKM Associates, No.25 Dr.Munusamy Garden, Avinashi Road, Coimbatore, represented by its Advisor, CA.K.Muthukrishnan., herein after referred to as the SECOND PARTY OF OTHER

PART, NOW, THEREFORE, in consideration of the mutual covenants and promises herein, the PARTIES agree as follows:

Clause.1 Objectives

- 1.1 To establish a collaborative framework for offering innovative, industry-relevant courses, internships, and training programs for students of the Commerce Club, Dr. N.G.P. Arts and Science College, in association with SRKM Associates
- 1.2. To jointly organize seminars, workshops, and guest lectures that bridge academic knowledge with industry practices, benefiting both students and professionals.
- 1.3. To collaborate on community outreach initiatives, promoting corporate social responsibility (CSR) and experiential learning for students.
- 1.4. To enhance academic and professional quality through active industry-academic interaction, internships, industrial visits, and mutual participation in curriculum development and review.


Clause 2. Implementation

2.1.1 The PARTIES agree to form an Implementation Committee comprising the following members:

- i) Principal, Dr. N.G.P. Arts and Science College, Coimbatore.
- ii) Advisor, SRKM Associates, Coimbatore

Clause 3. General Provisions

- 3.1 An **Implementation Committee**, comprising representatives from the Commerce Club, Dr. N.G.P. Arts and Science College, and SRKM Associates, shall determine the scope, nature, and schedule of collaborative programs, training sessions, internships, and other initiatives, in consultation with relevant faculty members and industry professionals.
- 3.2 The institution or organization hosting a particular event or activity shall be responsible for mobilizing the required resources and ensuring its effective execution.
- 3.3 Each PARTY shall independently undertake its respective responsibilities under this MoU without any financial commitment from the other PARTY. Neither PARTY shall be held liable for any financial obligation or expenditure incurred by the other, unless explicitly agreed upon in writing by both PARTIES in advance.

- 3.4 Any disputes or differences arising from the execution or interpretation of this MoU shall be resolved through mutual discussion and consensus. If unresolved at the operational level, the matter shall be escalated to senior officials from both PARTIES for final resolution.
- 3.5 This MoU shall not affect or limit any other agreements, collaborations, or partnerships that either PARTY may enter into independently with other organizations or institutions.

Clause 4. Tenure and Termination

- 4.1 This MoU shall become effective from 16 March 2026 upon the signatures of the authorized representatives of the PARTIES and shall remain valid for one year. It may be amended by mutual written agreement and may be terminated at any time by either PARTY upon giving one month's written notice to the other PARTY.
- 4.2 All joint activities that are in progress at the time of expiration or termination of this MoU may continue until their completion under the terms of this MoU.

Clause 5. Amendments

- 5.1 This Memorandum of Understanding (MoU) constitutes the complete and final understanding between the Commerce Club, Dr. N.G.P. Arts and Science College and SRKM Associates. ("PARTIES") and supersedes any prior discussions, communications, or agreements, whether oral or written, relating to the subject matter of this MoU.
- 5.2 No amendment, modification, or addition to this MoU shall be valid unless it is made in writing, duly signed by authorized representatives of both PARTIES, and explicitly stated as an amendment to this MoU. Such modifications shall become an integral part of this MoU and shall take effect from the date of execution, unless otherwise mutually agreed upon by the PARTIES.

Clause 6. Assignment

- 6.1 This MoU is based on the professional competence and expertise of each PARTY.
- 6.2 Therefore, neither PARTY shall transfer or assign this agreement, or any rights or obligations arising hereunder, in whole or in part, to any third party.


