



First Party and second party shall be hereinafter collectively referred to as “Parties” and individually as a “Party”.

Palaniswami, as its Chairman and Dr.Thavamani D. Palaniswami as its Managing Trustee and Secretary. The College has been recognized under 2(f) and 12(B) by UGC, New Delhi. The college was re-Accredited by NAAC with “A” Grade (2<sup>nd</sup> Cycle).

The second party, i.e., Dr. N.G.P. Institute of Technology (DrNGPIT) is an organization of KMCRET trust which was established in the year 2007 under the leadership of Dr.Nalla G. Palaniswami, as its Chairman and Dr.Thavamani D. Palaniswami as its Managing Trustee and Secretary. The college has been approved by AICTE, New Delhi & Affiliated to Anna University, Chennai also Recognized by UGC and Accredited by NAAC and NBA.

## WHEREAS:

- A. DrNGPIT has agreed to assist DrNGPASC with respect to use of its institute to provide support to M.Sc. Medical Physics Programme conducted by DrNGPASC.
- B. Towards this, the Parties hereby agree to enter into this Agreement to record their understanding in offering support at the DrNGPIT on terms and conditions as set out in this Agreement.

NOW, THIS AGREEMENT WITNESSETH AND IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

## 1. SCOPE OF THIS AGREEMENT

- 1.1 To permit the Students of the all programmes conducted by DrNGPASC to utilize the infrastructural and instrumentation facilities available at DrNGPIT, Coimbatore.
- 1.2 To conduct regular practical classes and end semester practical examinations at DrNGPIT for the students admitted to M.Sc. Medical Physics course at DrNGPASC.
- 1.3 To undertake collaborative research proposals jointly by DrNGPASC and DrNGPASC without any financial commitments.
- 1.4 To organize national and international level workshops / Seminars / Hands-on training for the benefit of DrNGPIT and DrNGPASC staff and students.

## 2. TERM & TERMINATION AND CONSEQUENCES OF TERMINATION:

### 2.1 TERM:

This Agreement shall be valid for a period of Five (5) years from the date of last signature by the Parties (“Term”), unless terminated earlier by the Parties as

provided hereinafter. Upon expiry of the Term, the Parties may renew the Term of the Agreement for such further period as mutually agreed to in writing by the Parties.

## 2.2 TERMINATION:

The DrNGPASC and DrNGPIT shall be entitled to terminate this Agreement by providing a written notice of two months to other, without assigning any reasons whatsoever.

## 2. STUDENTS SAFETY:

The DrNGPASC shall ensure that its students shall always conduct themselves in a disciplined manner and shall not indulge in any riotous activity and do nothing which would have adverse impact on working of the DrNGPIT or of maintaining discipline in the DrNGPIT. The students shall strictly adhere to all the policies laid down by DrNGPIT.

## 4. REPRESENTATIONS AND WARRANTIES OF THE DrNGPASC:

4.1 The DrNGPASC shall ensure that its students follow all rules and regulation of DrNGPIT pertaining to leave, discipline, Practical classes, Training and project work schedule, grooming and etiquettes etc. More than two incidents of indiscipline / non-cooperation will lead to intimation by DrNGPIT to the DrNGPASC for the termination of Practical classes, Training and project work period of any students without any notice or prior information.

4.2 The DrNGPASC shall ensure that the students to adhere to the attendance requirements as decided by DrNGPIT and DrNGPASC during the Practical classes, Training and Project work.

## 5. MISCELLANEOUS:

5.1 **Severability:** Each and every obligation under this Agreement shall be treated as a separate obligation and shall be severally enforceable as such and in the event of any obligation or obligations being or becoming unenforceable in whole or in part, the Parties shall negotiate, in good faith, a valid, legal and enforceable substitute provision or provisions, which most nearly effect the intention of the Parties.

5.2 **Counterparts:** This Agreement shall be executed in two counterparts, all of which shall constitute one and the same agreement.

5.3 **Financial Commitment:** There is no financial impediment for the both parties.
